Actions for Trustees:

An extra education committee date has been requested to take place on w/c 22nd June, please check your calendars for availability. The meeting is an opportunity to evaluate the schools' Risk Assessments and Health & Safety changes since the expansion of on-site provision.

School Improvement Update:

A short paper has been drawn together around the 'Recovery Curriculum', which draws on the work of Tom Sherrington, Barry Carpenter and Mary Myatt. These articles remind us that we need to consider at length the impact of recent school closure on pupils and that we cannot simply pick up where we left off. Rather, there is a significant need to re-establish routines and the conditions for effective learning. Both Carol Pearce and Jane Abbott are in the process of organising their School Improvement Partner visit to each school over the next few weeks. These meetings will provide an opportunity for them to undertake a conversation with each headteacher around school self-evaluation as well as to reflect on school priorities for 2020-21.

We are now in the process of drawing together the school improvement calendar and schedule of CPD for next year. We will in due course be requiring the input of all headteachers into the content of this programme. Further discussions to follow. We are also planning on establishing a calendar of training and support for GLAC members, details of which will be published in due course.

George Abbot Teaching School was recently successful in being awarded the contract to undertake training for secondary teachers in the new Relationships, Sex & Health Education (RSHE) curriculum. This free training will be provided for secondary teachers across the South East South London region.

The deadline for **SCC Statutory Audit of Safeguarding Arrangements** has been extended until 30th June 2020.

School Operations:

GEP Good Estates Management - School Capital Allocation

GEP schools are fortunate to have received a further £2.3m to help ensure our estates are in sound condition. We are currently awaiting finalised condition surveys that Baily Garner were able to conduct during lockdown, with support from school premises teams. We will therefore be able to propose the most suitable allocations and seek approval in our forthcoming trustee meeting this summer. To date, as trust of 7 schools we have benefited from £12m of such capital funding. Smaller trusts must bid for their allocations to central government and maintained schools rely on local government's approach to allocating funding, whereas we have received the 19th largest allocation of all multi-academy trusts this year.

SBM deadline: Schools should be aware via the SBM bulletin that schedules of existing SCA allocations and projects need to be updated prior to new allocations being made.

GEP Joint Purchasing – PPE and cleaning supplies

As a further benefit of being part of a trust, the GEP Estates Manager has co-ordinated central procurement of PPE equipment and cleaning supplies. This has involved sourcing a good supply chain, pulling together requests from schools with a coordinated PPE approach and then distributing these across schools with school premises staff working as a collective team across our trust. Our schools are therefore ready and prepared for the new term with gloves, aprons, masks, thermometers, hand sanitiser and cleaning fluid.

Centralised procurement is an ongoing ambition.

GEP Risk Management – Expansion of School provision from 1st June

In response to the coronavirus pandemic, GEP central support to schools continues to be extensive. In the last four weeks the COO and GEP Estates Manager have continued to interpret government guidance, provided resources (checklists, posters, risk assessment templates), and offered H&S and legal advice for schools to robustly assess the risks presented by wider expansion of provision from 1st June. Schools' 'reopening' plans have been reviewed by the GEP executive to ensure that such expansion strikes the right balance between minimising risk of coronavirus infection and an ambition to have more children return to onsite education. We have also been proactive in discussing these plans with unions and trustees.

Feedback from schools on the central support provided has been very positive – thank-you!

GEP IT Support Team – Home Learning & Remote Working

The network team have been busy supporting students, parents and staff continuously throughout lockdown to ensure everyone is ready and able for Home Learning. We are pleased to say that all schools have hugely benefited from the expertise of the GEP IT Network Team, who have worked in a coordinated manner across the schools in our trust. We have introduced remote lessons using Zoom Cloud Meetings, work submission using SharePoint and deploying other bespoke learning tools to each school.

We have been providing support and assistance to all through our Helpdesk system, which as you know has allowed us to keep track of the hundreds of requests we receive every week, but still allows us to interact with you all and provide that personal touch.

Since early March our team has received a total of 2435 individual tickets into this system and we have been able to close 2243. March alone saw over 1000 tickets closed, making it our busiest month of the year to date which is normally September with the start of the school year. These tickets can range from providing remote support and training to account support, setting up user devices, online services and much more. The team has been very grateful for the support and positive feedback we are receiving from our schools, parents and pupils, thank you.
